The Manitoba government is seeking highly motivated 2nd Class Power Engineers to work with Accommodation Services Division in Winnipeg. This position offers reliable and full time employment with a defined pension plan. The Manitoba government also provides an excellent benefits package which includes extended health, health spending, dental, vision, long term disability, supportive employment, sick leave, paid vacation and maternity/parental leave. Manitoba Finance provides ongoing professional and educational development for its employees.

## **Conditions of Employment:**

- Must be legally entitled to work in Canada
- Must have a 2nd Class Power Engineering Certification Registered with the Province of Manitoba.
- Must have a valid Class 5 Driver's Licence.
- Must be physically capable of performing the duties of the position, including wearing Personal Protective Equipment.
- Must have satisfactory Criminal Records Check, security check (if applicable) and Child Abuse Registry Check.
- Must be able to work at heights and in confined spaces.

## **Qualifications:**

### **Essential:**

- Manitoba 2nd Class Power Engineering certificate (Consideration may be given to a suitable candidate who holds a 3rd Class Power Engineering Certificate and shows demonstrated progress toward obtaining the 2nd Class Power Engineering Certificate).
- Experience carrying out repairs on all steam, oil, refrigeration and pneumatic equipment while working within Manitoba Code Regulations.
- Organizational and time management skills with the ability to plan and follow up.
- Interpersonal skills to communicate effectively and respectfully with internal and external contacts.
- Strong analytical and problem solving skills.
- Ability to work independently while demonstrating initiative.
- Knowledge of the Workplace Safety and Health Act, and any other relevant safety policies and legislation.

**Desired:**

- Experience working in a 1st or 2nd Class Steam Plant.
- Experience working with water treatment systems and life safety systems.
- Experience working with Building Management Systems.

**Duties:**

Reporting to the Chief Power Engineer, Power Engineers are responsible for the overall safe and efficient operation of a 1st Class High Pressure Heating Plant, and all of its auxiliaries. A Power Engineer will also supervise the operation of heating/cooling, water supply and electrical generating equipment, respond to fire alarms, and observe and record all readings relating to energy consumption, steam and water pressures and cooling systems. Power Engineers will be required to complete chemical testing and adding of chemicals for the boiler, chilled water and cooling tower systems, test run emergency stand-by generators, fire booster pumps, as well as following regulations set out by the Department of Labour with regards to safe operations and inspections. This position may provide guidance and ensure the quality of work of employees in less senior technical positions such as Assistant Operating Engineers and Maintenance Assistants.
